What is FCS?

FCS aims to identify the interrelation of health problems and housing stability.

Supported employment helps qualified Medicaid recipients participate in the competitive labor market and work in a preferred job with the level of support and services needed to obtain and maintain competitive employment in an integrated

work setting.



What is FCS? (cont.)

- FCS creates statewide, targeted home- and community-based services (HCBS) intended to help Medicaid beneficiaries with complex health needs transition to and maintain community placement.
- Supportive housing services and supported employment services are the core benefits of the FCS program.

What is FCS? (cont.)

- This is a five-year transformation project with Amerigroup as the third-party administrator (TPA) serving enrollees across the entire state of Washington.
- Individuals don't have to be enrolled with Amerigroup for Medicaid services.
- FCS does not replace existing services.

Amerigroup as FCS TPA

Overview:

- Contracted with the HCA
- Provides administrative oversight of:
 - Provider network
 - Service authorization
 - Claims payment and encounter tracking/reporting
 - Measuring outcomes and quality improvement
 - Sustainability plan
- FCS Advisory Council



Supportive Housing

What is supportive housing?

- It is ongoing supports to help people find and keep stable, independent housing.
- Services include:
 - Housing assessments.
 - Identifying housing resources.
 - Support obtaining a lease.
 - Independent living skills development.
 - Landlord relations.
 - Crisis management.



Supported Employment

What is supported employment?

- Supported employment services help people find jobs (in competitive or customized work settings or self-employment) and gain the skills necessary to be successful.
- It is based on the Individual Placement and Support (IPS) model
- Services include:
 - Vocational/job-related discovery or assessment.
 - Planning for employment.
 - Job placement, development, coaching.
 - Skills-building for negotiating with prospective employers.



- Tool to quickly evaluate if a potential enrollee may be eligible for Supportive Housing and/or Supported Employment

Eligibility

- FCS services are targeted benefits not entitlements for all enrollees.
- Amerigroup will determine eligibility.
- Individuals must be enrolled in Medicaid.
- Individuals must meet age requirements (18+ for supportive housing, 16+ for supported enrollment).
- Individuals must have at least one assessed health-needs-based criteria.
- Individuals must meet at least one risk factor.
